IM Medical Limited (“the Company”) presents its Appendix 4C Cash Flow Statement for the quarter ended 31 March 2010.

Net operating cash outflows were \$0.389m, whilst Net financing cash inflows for the March quarter were \$0.386m following a number of drawdowns under the \$5m Fortrend Standby Subscription Agreement.

The company had cash balances of \$0.025m and \$3.75m drawdown facilities available under the Fortrend Standby Subscription Agreement.

The company has sold 3 portable Intelliheart units to its rural distributors in the quarter and expects the proceeds to be paid in the June quarter.

Directors and Management are still in discussions relating to finalisation of conditions precedent outlined in the Business Sale Agreement with the Mark Scott Group of Radiology businesses.
